



Liquidators' First Report for Supie Limited, Workerly Limited and Bevie Limited (All In Liquidation) (the Companies)

Introduction

As you will be aware, Richard Nacey (Insolvency Practitioner Registration No. 69) and Stephen White (Insolvency Practitioner Registration No. 137), Licensed Insolvency Practitioners (NZ) of PricewaterhouseCoopers New Zealand (PwC or the Firm) were appointed joint and several Voluntary Administrators of the Companies on 30 October 2023 pursuant to section 239I of the Companies Act 1993 (the Act).

A watershed meeting to decide the future of the Companies was held on 9 November 2023, and at that meeting a resolution was passed to appoint Richard Nacey and Stephen White as joint and several Liquidators of the Companies at 4:42pm under section 239ABU(b) of the Act.

We have made the appropriate enquiries and are of the opinion that we are independent and are not barred from acting under section 280 of the Act. Please see our full Declaration and Interests Statement at Appendix E.

Liquidators of insolvent companies are required to be licensed insolvency practitioners. More information about the regulation of insolvency practitioners is available from the Registrar of Companies.

You are advised that section 314 of the Companies Act 1993 permits any creditor or shareholder of the Companies to request us in writing (at any time during the course of the liquidation) to call a meeting of creditors or shareholders for the purpose of:

- voting on a proposal that a liquidation committee be appointed to act with us; and
- to choose the members of the committee.

Restrictions

This report is based on information we currently have and is subject to the Restrictions in Appendix A. Liquidators' reports are sent out within five working days after the appointment of liquidators, once every six months and upon completion of the liquidation.

The Companies operated as an online grocery business with Supie Limited (In Liquidation) being the main trading entity. Workerly Limited (In Liquidation) was primarily responsible for employing and managing staff while Belive Limited (In Liquidation) held a liquor licence and operated as the online alcohol retailer within the Supie business.

Noting that the Supie business was a start-up enterprise that operated in a highly competitive sector for approximately two and a half years before it was placed into voluntary administration, we have been advised that the reasons for the Companies' insolvency was primarily due to a lack of sales volume and scale to operate the business profitably.

Further, we understand that the business was actively attracting investment capital to fund growth but was unable to secure the required level of investment. The Supie business was unable to continue operating without additional capital and as such, the director made the decision to place the Companies into voluntary administration on 30 October 2023. As there were insufficient funds available to continue to operate the Supie business, the Administrators made the decision to close down the Supie business, which resulted in the termination of staff employment contracts.

On 9 November 2023, it was resolved that the Companies would be placed into liquidation by resolution of the creditors at a jointly held watershed meeting. The Liquidators will carry out further investigation into the events leading up to the Companies' failure.

The Liquidators have access to the financial records of the Companies and historical management accounts to October 2023. We understand that the Companies did not produce annual financial statements.

We have been in communication with the director, who has been very cooperative throughout the voluntary administration and subsequent liquidation processes. The Liquidators will make enquiries / investigate the directors' conduct leading up to the insolvency in due course.



A Statement of Affairs of the Companies summarising their known assets and liabilities is enclosed at Appendix C.

Identified Assets

At the date of liquidation, the Companies' balance sheet reported assets primarily related to inventory, accounts receivable, technology and IT infrastructure as well as intellectual property assets.

The Voluntary Administrators had been working through a process to return highly perishable inventory to suppliers with valid security interests or retention of title claims. The Voluntary Administrators had also made a small amount of realisations relating to unencumbered inventory. The Liquidators intend to continue working through this process.

According to the books and records of the Companies, there are approximately four debtors owing approximately \$16,680 to the Companies. The Liquidators intend to pursue the recovery of outstanding accounts receivable.

The Voluntary Administrators commenced an accelerated sales campaign to identify any potential interested parties to acquire the technology, IT infrastructure and intellectual property of the Supie business. The Liquidators intend to continue progressing this process and will update creditors in due course.

The Companies' records do not appear to reflect an overdrawn shareholders current account.

Other potential avenues for recovery

We will investigate the actions of the directors and the affairs of the Companies to identify if there are any insolvent transactions, avenues for recovery or breaches of law which we may refer to the authorities for further investigation.

If you have any information that you believe would lead to realisations for the benefit of creditors, please send us detailed evidence for our consideration.

Workerly Limited (In Liquidation):

There are no financing statements registered in respect of Workerly Limited.

In relation to each of these creditors we advise as follows:

1. The Voluntary Administrators contacted the secured creditor. Discussions regarding the security remain ongoing with the Liquidators.
2. The Voluntary Administrators wrote to the secured creditor, but no response has been received as at the date of this report. The Liquidators will issue further communication and continue to liaise with the secured party.
3. The Voluntary Administrators have contacted the secured creditor and subsequently received correspondence they intend to enforce their security interest.
4. The Liquidators have contacted the secured creditor and subsequently received confirmation that the security has been discharged.

The Liquidators will continue to work with secured creditors while attempting to realise a sale of the Companies' assets.

Preferential Creditors

Employees

Supie Limited (In Liquidation) employed four active staff as at the date of liquidation. These staff were re-employed by the Voluntary Administrators to assist them on a casual basis. The Liquidators may continue to use these casual staff members if they are required and available.

Workerly Limited (In Liquidation) previously employed approximately 118 staff at the date the Voluntary Administrators were appointed on a mixture of casual and long-term contracts. According to the financial records of Workerly Limited (In Liquidation) \$120,797 in wages and/or holiday pay remains outstanding to approximately 89 employees.

Other Preferential Creditors

Inland Revenue has filed a preferential claim for outstanding GST, PAYE and other related employee deductions for \$881,770 for Workerly Limited (In Liquidation) and \$2,040 for Bevie Limited (In Liquidation).

Unsecured Creditors

Based on the Companies' books and records we understand there are 4,202 unsecured creditors owed approximately \$2,163,080 across the Companies as outlined in the table below.
